9. Self-reports	
Are participants asked to report personal experiences?	
10. Intimacy/stigmatisation:	
Are participants asked to answer intimate questions (e.g., distressing personal experiences	
or traumas, sexuality, drug use, addictions or stimulant abuse, or political beliefs)?	
11 Ethically problematic behaviour	
Are participants induced to behave in an ethically problematic manner (aggressive	
behaviour, punishment, etc.)?	
12. Administration of substances	
Are participants given medication, placebos, food supplements or other substances as part	
of the study?	
13. Deception	
Are the participants deceived about the object or aim of the research project?	
14. Confidentiality	
Are participants informed about data protection? Is the data anonymised/pseudonymised,	
stored, processed and protected against unauthorised access?	
15 Right to data deletion	
Can participants request the deletion/destruction of their personal data within a certain	
period of time and will they be informed of this?
